Recommend refusal. The proposed 4.9 metre long two storey rear extension would be overbearing to the occupiers of both 233 and 237 Hinton Way and would cut out light to the rear first floor windows of 237 Hinton Way.

S/1604/16/FL 32 Buristead Rd Two storey side and rear extension and a new porch.

No recommendation. Although the majority of 2 storey side extensions in Buristead Rd have reflected the existing architecture, we do not believe this contemporary design which should not adversely impact on the neighbours could be refused. We do however have concerns about the proposed material for the cladding which may appear overly dominant to the adjoining properties

S/1669/16/FL 7 Church St. Dropped kerb. No objections.

S/1515/16/FL 13 Red Hill Lane. Proposed single storey rear and two storey side extension. No objections to original design – comments awaited on amended design.

S/1643/16/FL 13 Woodlands Rd Rear and side extensions and replacement windows.

No recommendation. In the light of the previous approval no objections to the principle of extending the house but would value the Conservation Officer's opinion on the proposed two storey flat roof.

S/1758/16/FL 6 Mingle Lane Erection of black metal railings above brick wall. As similar railings in Mingle Lane have planting behind them could some hedging be planted to soften the railings? No recommendation.
